## C. R. RAO\*



Calyampudi Radhakrishna Rao was born on Septempter 10, 1920. He is a very highly reputed Indian Statistician who is awarded Fellow of Royal Society (FRS). He has been Professor Emeritus at Penn University and Research Professor at the Universities of Buffalo. He has done pioneering research work in Estimation Theory,

Statistical Inference, Linear Models, Multivariate Analysis, Combinatorial Design, Biometry, Genetics, Generalized Matrix Inverses, Functional Equations etc. He is very famous by his works-cramer Rao Inequality, Rao Blackwell Theorem, Orthogonal Array etc. ASA has described him as "a living legend whose work has influenced not just statistics but has had far reaching implications for the fields as varied as economics, genesis, anthropology, geology, national planning, demography, biometrics and medicine."

The Times of India listed Rao as one of the top 10 Indian scientists of all times. He was awarded "PADMA VIBHUSHAN" by Govt. of India in 2001.
